## Highlights for October:

- Parent teacher conferences are set for Thursday, October 17th. I'll set up a time for your conference and send a reminder will go home next Wednesday. If you can't keep your scheduled time please contact me and we can set an alternative time.
- I'll give out progress reports to the students on Friday, the 4th. This is a great time to talk about strengths, weaknesses, goals, and how to study.
- In October I will have the students write a short report on a chosen saint and then create a life-sized picture of that saint to hang in the church as All Saint's Day approaches.
- The first Math tests will be next week. How to study for a Math test—besides their text book and two days of review, they all have a Notes Book which contains examples and explanations of the lessons in chapter 1 to study from. After any test I allow the students to make corrections using their book or notes. They can turn the corrections in with Mom or Dad's signature for 5 extra points since not everyone is a great test-taker. 4<sup>th</sup> graders will then perfect their skills at adding and subtracting, 5<sup>th</sup> and 6<sup>th</sup> graders will jump into multiplication.
- Language Arts—everyone is studying nouns and learning/remembering how to diagram sentences.
- History—everyone will complete a quick unit on oceans, continents, latitude, and longitude. Then 5<sup>th</sup> and 6<sup>th</sup> will dive into the ancient civilization of Mesopotamia. 4<sup>th</sup> graders are starting Wisconsin history.

- 5<sup>th</sup> and 4<sup>th</sup> grade Scientists continue with cellular structure and organizing life into kingdoms with a focus on mammals and plants. The next unit includes information on how traits are passed from parent to offspring.
- 6<sup>th</sup> grade Science work is on cellular structure and function. They will look closer at the function of each cell part as they make a cell model.
- Reading finds the 6<sup>th</sup> graders reading *Esperanza Rising*, wondering how she will build a new life as an immigrant worker in America. The 5<sup>th</sup> graders are halfway through *Frindle*, wondering what will happen to Nick and his new idea. The 4<sup>th</sup> graders are in *The Birchbark House*, wondering what new adventures wait for Omakayas and her family.
- Religion is continuing to review the sacraments using information from the textbook and other Catholic sources.

## 2) ELEMENTARY STUDENTS' DRESS CODE

Standards for dress at St. Charles School, which comply with the standards set in all of the Catholic elementary schools in the Diocese of La Crosse (DSR 5691), are as follows:

### 1. What is to be Worn

**Collared shirts:** This includes button down or collared polo shirts. No T-shirts are permitted as primary wear during the school day, except for the official St. Charles School t-shirt allowed on certain days by the administration. Shirts that can be buttoned are to be buttoned appropriately. In most cases, this would mean up to the second to the top button on a normal shirt or blouse. Blouses and shirts should cover the midriff during all movement and activity.

**Pants:** Pants must be dress pants/slacks, khaki, or denim (no denim on Mass days). Khaki or denim shorts can be worn when the weather warrants it, usually from May 1 to October 1. All pants/slacks, jeans must be in good condition and not have any holes, ragged edges, bleached-out or tie-dyed markings.

**Dresses:** Dresses, skirts, skorts, shorts, etc., are to be longer than three inches above the knee. Dresses do not have to be collared. Leggings, shorts, or yoga pants must be worn under dresses or skirts.

**Sweatshirts:** Sweatshirts, hooded or otherwise, which have no logo or has the St. Charles, Aquinas, De Soto, or that individual student's non-school sports team logo.

**Outdoor Wear:** Outdoor wear includes, but is not limited to, coats, hats, jackets, windbreakers, hoods on sweatshirts, etc... No outdoor wear is to be worn within the school building during the regular school day without special permission of the administration. If a sweatshirt is going to be worn that day for outdoor wear, the student is to bring a separate sweatshirt for indoor wear.

**Shoes:** Shoes must be worn during the school day. The type of shoe is not to pose a safety hazard. Sandals must have a back strap. Closed-toed shoes must be worn for outdoor recess and P.E. activities. Shoes that have laces are to be tied. Flip-flops and other footwear that does not have a backstrap are not permitted.

### 2. Mass Day Uniform

On days when all the students attend Mass, which is typically Tuesdays and Holy Days of Obligation, students are required to wear the Mass Uniform, which is:

The St. Charles red shirt (t-shirt or polo) and black pants. For the girls only, they can wear a skirt with leggings, shorts, or yoga pants worn underneath.

### 3. Anything outside of the above is not permitted. This includes, but is not limited to:

- T-shirts (exception: The St. Charles official t-shirt on certain days).
- Pants that are over-sized or ill-fitting, torn, ragged, or bleached out.
- Sweat pants, Athletic wear (including athletic shorts), Leisure wear, Pajama bottoms.
- Leggings or yoga pants, unless they are worn under dresses or with a tunic top.

-Any clothing that is deemed by the administration to be less than modest or not in accord with the dignity of the human person.

#### **4. Other Dress Code Rules**

- a. Hairstyles must be clean, cut to a reasonable length, and be a reasonably natural color.
- b. Any accessory that draws undue attention to a student is not permitted. This includes, but is not limited to, makeup, hairstyles, long looping chains, and all unreasonable body jewelry. This also includes, but is not limited to jewelry worn in the tongue, nose, lips, eyebrows, excessive piercings in the ear, etc.
- c. Body art (tattoos) is not to be publicly visible.
- d. Hats, caps, bandanas or other types of headwear are not to be worn in the school building during the regular school day.
- e. At all times there is not to be any saying, picture, or reference on clothing that is inconsistent with Catholic faith and morals. Items which reference drugs or alcohol, songs, or musical groups whose lyrics have content inconsistent with Catholic teaching, are inappropriate for wear.
- f. These directives apply to all students for the entire school year. Exemptions are not to be granted for special groups.
- g. When there is a need for special occasion dress (e.g. field trips, etc...), all dress must fit within the school's guidelines for modesty and safety. The school administration reserves the right not to allow participation in activities if, in the judgment of the administration, dress does not conform to the administration's standards of modesty and safety.

# Influenza (Flu) Vaccine (Inactivated or Recombinant): *What you need to know*

### 1. Why get vaccinated?

**Influenza vaccine** can prevent **influenza (flu)**.

**Flu** is a contagious disease that spreads around the United States every year, usually between October and May. Anyone can get the flu, but it is more dangerous for some people. Infants and young children, people 65 years and older, pregnant people, and people with certain health conditions or a weakened immune system are at greatest risk of flu complications.

Pneumonia, bronchitis, sinus infections, and ear infections are examples of flu-related complications. If you have a medical condition, such as heart disease, cancer, or diabetes, flu can make it worse.

Flu can cause fever and chills, sore throat, muscle aches, fatigue, cough, headache, and runny or stuffy nose. Some people may have vomiting and diarrhea, though this is more common in children than adults.

In an average year, **thousands of people in the United States die from flu**, and many more are hospitalized. Flu vaccine prevents millions of illnesses and flu-related visits to the doctor each year.

### 2. Influenza vaccines

CDC recommends everyone 6 months and older get vaccinated every flu season. **Children 6 months through 8 years of age** may need 2 doses during a single flu season. **Everyone else** needs only 1 dose each flu season.

It takes about 2 weeks for protection to develop after vaccination.

There are many flu viruses, and they are always changing. Each year a new flu vaccine is made to protect against the influenza viruses believed to be likely to cause disease in the upcoming flu season.

Even when the vaccine doesn't exactly match these viruses, it may still provide some protection.

Influenza vaccine **does not** cause flu.

Influenza vaccine may be given at the same time as other vaccines.

### 3. Talk with your health care provider

Tell your vaccination provider if the person getting the vaccine:

- Has had an **allergic reaction** after a **previous dose of influenza vaccine**, or has any **severe, life-threatening allergies**
- Has ever had **Guillain-Barré Syndrome** (also called "GBS")

In some cases, your health care provider may decide to postpone influenza vaccination until a future visit.

Influenza vaccine can be administered at any time during pregnancy. People who are or will be pregnant during influenza season should receive inactivated influenza vaccine.

People with minor illnesses, such as a cold, may be vaccinated. People who are moderately or severely ill should usually wait until they recover before getting influenza vaccine.

Your health care provider can give you more information.

#### 4. Risks of a vaccine reaction

---

- Soreness, redness, and swelling where the shot is given, fever, muscle aches, and headache can happen after influenza vaccination.
- There may be a very small increased risk of Guillain-Barré Syndrome (GBS) after inactivated influenza vaccine (the flu shot).

Young children who get the flu shot along with pneumococcal vaccine (PCV13) and/or DTaP vaccine at the same time might be slightly more likely to have a seizure caused by fever. Tell your health care provider if a child who is getting flu vaccine has ever had a seizure.

People sometimes faint after medical procedures, including vaccination. Tell your provider if you feel dizzy or have vision changes or ringing in the ears.

As with any medicine, there is a very remote chance of a vaccine causing a severe allergic reaction, other serious injury, or death.

#### 5. What if there is a serious problem?

---

An allergic reaction could occur after the vaccinated person leaves the clinic. If you see signs of a severe allergic reaction (hives, swelling of the face and throat, difficulty breathing, a fast heartbeat, dizziness, or weakness), call 9-1-1 and get the person to the nearest hospital.

For other signs that concern you, call your health care provider.

Adverse reactions should be reported to the Vaccine Adverse Event Reporting System (VAERS). Your health care provider will usually file this report, or you can do it yourself. Visit the VAERS website at [www.vaers.hhs.gov](http://www.vaers.hhs.gov) or call 1-800-822-7967. *VAERS is only for reporting reactions, and VAERS staff members do not give medical advice.*

#### 6. The National Vaccine Injury Compensation Program

---

The National Vaccine Injury Compensation Program (VICP) is a federal program that was created to compensate people who may have been injured by certain vaccines. Claims regarding alleged injury or death due to vaccination have a time limit for filing, which may be as short as two years.
